- how **team and self-development** can be better integrated into the orchestra's daily routine

Our conference title does not only mean a new empathic/kind leadership style for the tasks of the future. It also stands in the area of tension between hierarchical and demoralizing structures and the recurring abuse of power - employees are not pawns, but the most valuable resource in people-focused operations. Against the backdrop of the predicted shortage of skilled workers in society as a whole and in the midst of the Long Covid of arts employees, theaters and orchestras should also ask themselves as employers how they can be attractive to potential employees in order to find and retain them.

On the first day, we will focus on us: Together we, we will sharpen and update the profile of the orchestra manager\* and thus find a better common understanding and a sense of we. In addition, we would like to focus more on your very own topics. Besides the classical workshops, we offer you the opportunity on Sunday afternoon to discuss in small groups your personally pressing technical question (BYOT) or to present your best practice example as a solution for your colleagues present.

On Monday, we want to develop an understanding for and the specifics of „leadership in the orchestra (management)“, dedicate ourselves to the topic of mental health, and reflect on and reflect upon interaction and communication with colleagues and employees.
